# A Great-horned Owl's Sunday Freedom Flight

At last! Sunday, August 27 was finally here – the day for the long-awaited-for Raptor Event at IAIA Hogan. As a few of us began to set up chairs and items to benefit the Santa Fe Raptor Center in the Hogan, Lori Paras, director of the Raptor Center



walked in with two assistants and three education birds, not to mention the crate with the Great-horned owl which would be released at the end of the program.

The Santa Fe Raptor Center rescues, rehabilitates, and releases all kinds of raptors. The center is located in El Rito and its web site is <u>http://santaferaptorcenter.org/</u> The center is a 501 (c) (3) non-profit organization.

As people began arriving, they stopped at our table to peruse and purchase handmade items. On display were designer-made greeting cards, hand-stuffed felt owls, and rubber-stamped magnets. Cards were two for \$5; owls and magnets



were also \$5. Proceeds from the sale of these items was given directly to Lori in support of the Santa Fe Raptor Center which helps feed and rehabilitate rescued raptors.



One by one the assistants brought out the education birds. The first was a beautiful Barn owl, and the second, a regal Great-horned owl. Lori spoke about the two species and answered many questions from the audience. Later, she opened the cage of the third education bird and pulled out a Red-tailed hawk. The presentation was one the very best in the years that she has been partnering with La Entrada for the Raptor Event.

After some snacks and beverages and a last look and purchase of hand-crafted items, the attendees made their way outside to a field on the east side of the Hogan. One of the assistant's opened the crate that enclosed the Great-horned owl and, holding her up proudly, Madame owl posed coyly for photographs. With her "horns" up and enormous wingspan ( can be up to 3' 6"), she was truly a magnificent bird! Flying off into a northeast direction once released, the crowd cheered with enthusiasm.

Even though attendance was down from last year, everyone genuinely appeared to enjoy the experience! Total donation to the Santa Fe Raptor Center was around \$600. The Santa Fe

Raptor Center board is taking the remaining cards and items to sell at its various events in the future, so our donation is a higher amount. This year's Raptor Event was a great success and we have some beautiful pictures to share!



About 60 residents attended La Entrada's Fiesta Picnic on September 9. The day was beautiful though quite windy, although that didn't stop anyone from having a good time meeting and catching up with his neighbors. It was especially nice to see several new families with children in attendance.



Food was plentiful and attendees had their choice of red chili beef enchiladas or green chili chicken enchiladas, or even better both polished off with a few brownies for dessert. Tomasita's catered the event and rave reviews could be heard all around.

Attendees were asked to bring a food item to help jumpstart our annual food drive to benefit the Food Depot. Neighbors were very generous and we collected about 175 lbs. of food in advance of the official Food Drive on September 16. Thank you to all who participated!

The beautiful cards created by members of the Rancho Viejo Ladies Group to support the Raptor Center were presented for sale and we raised an additional \$90 for the Raptor Center over the amount raised at that event. See you next year!

# **Pilot Flying J Community Meeting**

Santa Fe Community College - September 25, 2017

Because James Siebert & Associates and Pilot Flying J's recent application to Santa Fe County had to be re-submitted, another community meeting was scheduled. The purpose of the September 25 meeting was to focus on Pilot's Conceptual Plan for two segments adjacent to the main terminal parcel. Santa Fe County is requesting a plan for possible development of the land to the northeast and southwest of the Pilot site. Well over 200 people were in attendance at the meeting.

Technology issues with Mr. Siebert's slideshow caused the meeting to begin 15 minutes late, and it ended 30 minutes later than scheduled. After outlining meeting ground rules, Mr Siebert began the presentation showing slides of the 26-acre subdivision. The Conceptual Plan's goal, he said, is to present a vision to the county in terms of the impacts



of development like water rights, sewer, and open space. The presentation included maps of the proposed site, including the SLDC (Sustainable Land Development Code) zoning map depicting the site as an employment center.


Mr. Siebert discussed three phases of development of the 26acre site. The first phase will be the Pilot Flying J Truck Center, occurring possibly in 2018 – 2019.



#### **Pilot Flying J Truck Terminal, Continued**

The second phase will be on the northeast side of the proposed truck center with the possibility of two 100-room hotels slated for 2021–2026. The third phase to the southwest of the site will provide a sit-down restaurant, retail, a warehouse, and light industry targeted for 2030. These proposed constructions are conceptual and taken from a list of possible land uses zoned for an employment center; however, this does not mean that these will be the specific structures for development.

In the presentation, Mr. Siebert talked about changes to the truck center site including the road being placed further away from Rt. 14 and the need for 50% of the land allocated to Open Space. Since the proposed construction would be almost 5 acres short of the required Open Space per SLDC, land behind ATC, in the arroyo, near trail sites, would be designated for the needed Open Space.

#### Pilot Flying J Community Meeting, Continued

There are plans for a waste water lift station in the front of the truck center. This waste water, through a series of different sized pipes, would flow south on Rt. 14 to a quill plant near the State Penitentiary. The traffic report revealed that a northbound left turn lane at the Rt. 14 and Rancho Viejo Blvd. intersection would be 400 ft. in length, and a southbound right turn deceleration lane would be 270 ft. Road improvements would be based on traffic impact and demand. The building of a masonry wall and berm was also discussed.

After the completion of the presentation, audience members who had previously signed in intent on asking questions were called upon. Of the 18 people who spoke, only one attendee stated he was in favor of the proposed Pilot Flying J Truck Stop.

If the application is approved, there will be a Public Hearing with the Hearing Officer, another with the Planning Commission, and finally, the Board of County Commissioners. ### **Construction Update**

The La Entrada Phase 1, Sub-phase 1 subdivision plat has been recorded. This has brought 58 new lots into La Entrada. With this new inventory of larger lots, Estancia Homes will be releasing 7 new floor plans! The new larger plans being offered range in size from 1,440 square feet to 2,884 square feet. In addition, we will retain 4 of the current plans ranging in size from 1,367 to 1,757 square feet. This is exciting and you will notice more construction shortly.





As part of Sub-phase 1 there are two parks. A continuation of the Spine Park and what we call the T Park (I would think there is a naming opportunity here). These parks are still under construction with the concrete finishing up and the planting to follow, but they will not be complete until spring 2018.

The entry landscaping on Rancho Viejo Boulevard and Via Punta Nuevo is being enhanced with walls installed around utility infrastructure to improve the appearance, and a large number of new plantings will benefit the entire area. Stop by the sales office and see the new offerings.

It has been a busy summer with La Entrada events. Our first event was the Santa Fe Raptor Center Presentation at the IAIA Hogan on Sun. Aug 27th. While the crowd was smaller this year, Raptor Center director Lori Paras's presentation was the best we have ever had. There were three education birds, great information, and many photo opportunities. As everyone began to depart the Hogan for the release of a Great-horned owl, the Raptor Center staff kindly held onto the beautiful bird for long moments so that visitors could get that special shot before it was released. Between the raptor event and the Fiesta Picnic, approximately \$600 in handmade cards, magnets, and felt owls was sold. That money was given to the Santa Fe Raptor Center to help feed and rehabilitate the birds. All remaining cards and items have been given to the Raptor Center for them to sell at their events.

The Fiesta Picnic which was held at the La Entrada Park on Saturday, September 9 in the afternoon. Approximately 60 residents attended and enjoyed food catered by Tomasita's Restaurant. We collected around 175-lbs of canned goods to jump-start our annual Food Drive. The raptor event items were available for purchase, and there was also information about the Rancho Viejo Neighborhood Watch.

The following Saturday, September 16 was the 6th Annual Santa Fe Neighbor to Neighbor Food Drive, held in conjunction with our Copier Paper Drive for the Amy Biehl Community School. While totals are not official yet as of this report, we anticipate meeting our goal of 1500-lbs of non-perishable food and monetary donations. We collected 49 reams of copier paper.

We continue to collect Box Tops for Education. The box tops should be placed in the plastic shoebox on the porch of the Dillon home at 85 Via Orilla Dorado.

Mark your calendars for our Annual Holiday Party on **Saturday, December 16, 2017**, which will be held at the sales office on Calle Agua Clara. More information is to come.

Welcome to Autumn! Summer is over and hopefully you were successful with your landscaping and other outdoor projects. For those of you who have sought DRC approval - Thank You! For those of you who did not - PLEASE send in a submission for review and approval.

As a reminder, approval from the Design Review Committee (DRC) is required for all changes or additions to landscaping: walls, fences and gates, changes and additions to outdoor lighting, awnings/shades, fire pits. kivas or BBQ pits, flagpoles, portals, patio covers and patio additions, storage sheds, incidental structures, gazebos, ramadas, and shade structures, swing sets,

trampolines and play equipment, exterior window coverings or treatments and placement of yard ornaments. We ask that you submit your screen/security door requests to the committee prior to purchase and installation. I'd like to stress that black or white doors are not an acceptable color. Such doors must be painted either your door or trim color.

#### Paper Drive




#### August/September Activities





#### Large Item Pickup

The date for large item pick up within La Entrada residential areas is the third Friday of each month. The next date of service will be **Friday**, **October 20** and **November 17.** 

Residents must call Michael Smith at 954-4479 before the date to arrange for large item pick up. Please provide your address, telephone number and description of item(s). Remember to sign up no later than the Monday prior to the Friday pick up date.

Types of items allowed: furniture, yard waste, appliances.

Not Allowed: Most electronics, oil or household chemicals.

### **Recycling Reminders**

Paper, clean plastics and cardboard can be mixed together in the cart. However, No **GLASS** should ever be put into the recycle bin. If you wish to recycle glass, you can do so at the Rancho Viejo Recycling Center.



If a specific homeowner does put glass into his recycling cart on a regular basis they will be warned, and, should that practice continue, MCT will no longer provide recycle pick-up at the home.

Also please note that the garage cart and recycle cart need to be placed at least 3 feet apart.

In October, recycle pick-ups will be on October 11 and 25, and November pick-ups will be on November 18 and 22.

## **Resident Parking Concerns**

Several residents have written to and spoken to Michael Smith in reference to vehicle parking within the LaEntrada HOA. The info below is from the LaEntrada Residents Handbook on page 25.

6. Parking of vehicles on sidewalks, landscaped or seeded areas is prohibited.

This is because the HOA maintains the sidewalks, landscaped and seeded areas and any damage to irrigation infrastructure or damage to sidewalks is a cost to the HOA and could result in future increases to cover repair.

Also, parking on sidewalks or blocking sidewalks could result in fines or lawsuits for ADA violation.

Please be considerate of your partner homeowners when you park your vehicles, violations should be communicated to Michael Smith including a photo of car and license and location of noncompliance parking.

Put a sticker or note inside YOUR box that says "NO ADVO"

• Take advertisements, grocery sales, etc ... home and recycle.
